



Hull City Promotion

Terms & Conditions of Promotion

1. Donation to Hull City Football in the Community

- (a) A £20 donation to Hull City Football in the Community (referred to in these Terms and Conditions as the “**promotion donation**”) will be made by Gosschalks for every UK resident over the age of 18 who instructs Gosschalks to undertake legal work which qualifies for the promotion during the 2008/9 Barclays Premier league season (subject to the other terms and conditions detailed below).
- (b) Hull City Football in the Community is a registered UK Charity (number 1092287) which aims to further and assist in the education (on a social and physical basis) of children attending schools within the East Yorkshire and Humberside and surrounding area through the game of football (including its history and rules) and other sports activities.
- (c) Each £20 promotion donation will be made only after the qualifying legal work has been completed and Gosschalks’ invoice has been paid in full. No promotion donation will be made (and Season Ticket Holders will not be entitled to the promotion discount against Gosschalks’ legal fees as detailed in section 2 below) if the instructions to Gosschalks are withdrawn before completion of the matter. In relation to a residential conveyancing matter, if Gosschalks acts for the same client on an associated sale and purchase, only one promotion donation will be made.
- (d) Gosschalks has imposed no limit on the number of £20 promotion donations which can potentially be made to Hull City Football in the Community under the terms of the promotion.

2. Discount against Legal Fees

- (a) A 10% discount off Gosschalks’ legal fees (referred to in these Terms and Conditions as the “**promotion discount**”) is available (in addition to the promotion donation being made as described in section 1 above) in relation to legal work qualifying for the promotion undertaken by Gosschalks for UK residents over the age of 18 who are Season Ticket Holders at Hull City AFC during the 2008/9 Barclays Premier League season. (All persons wishing to qualify for the promotion discount will be required to produce an original 2008/9 Season Ticket in their own name to prove they are eligible, failing which the promotion discount will not apply. Photocopies of Season Tickets are not acceptable).
- (b) The maximum value of the 10% promotion discount which is available in relation to each separate legal matter qualifying for the promotion is £2,000 (exclusive of VAT). The promotion discount applies only to Gosschalks’ legal fees (and any VAT payable on the discounted amount), and does not apply to any applicable disbursements, expenses and third party costs (for example search fees, stamp duty, land registry fees, expert and court fees, reprographics expenses, telegraphic transfer fees, or VAT, which will be charged for in full).

3. **Legal Work which qualifies for the promotion**

- (a) The promotion (both the promotion donation and the promotion discount) applies only to those types of legal work/matters listed in section 3(b) below which are undertaken by Gosschalks directly for private individual clients, and which commence during the 2008/9 Barclays Premier League season. It is not available in relation to any existing legal work/matters, or in relation to any legal work which Gosschalks undertakes for commercial clients (namely persons, firms or companies Gosschalks acts for in the course of their business or profession).
- (b) The promotion applies only to the following types of legal work undertaken by Gosschalks:
- Residential conveyancing
 - Home Information packs
 - Probate and Administration of Estates
 - Wills
 - Family and matrimonial
 - Employment advice (to employees)
 - Personal injury/accident claims
 - General litigation

Exclusions: Home Information Packs are excluded from the promotion unless Gosschalks also deals with the residential conveyancing relating to the sale of the same property. Personal injury/accident claims will not be eligible for the promotion discount but will be eligible for the promotion donation (subject to the other terms and conditions of the promotion). The production of Wills will not be eligible for the promotion donation but will be eligible for the promotion discount (subject to the other terms and conditions of the promotion).

4. **Applications & operation of the promotion**

- (a) Applications to participate in the promotion should be made to the solicitor/legal adviser at Gosschalks who is responsible for dealing with the legal work within 14 days of Gosschalks receiving instructions to deal with the legal work concerned, by completing a promotion application form. Any applications made after this time will be considered by the solicitor/legal adviser in consultation with the partners at Gosschalks, and may be refused. Gosschalks will confirm eligibility for the promotion in writing as soon as reasonably practicable after application.
- (b) The promotion starts on 11th September 2008 and runs during the 2008/9 Barclays Premier League season ending on 24th May 2009. The closing date for applications to participate in the promotion is therefore 24th May 2009. Gosschalks however reserves the right to suspend, postpone or cease operation of the promotion at any time. In the event of the promotion being suspended, postponed or ceased, no new applications to participate in the promotion will be considered, but Gosschalks will honour the terms of the promotion in relation to all persons whose applications have been accepted at that time.
- (c) The promotion is open to existing clients of Gosschalks but not to partners or employees of Gosschalks.
- (d) Gosschalks' decision on the eligibility of individual persons and legal work qualifying for the promotion shall be final.
- (e) This promotion is operated by Gosschalks solicitors, whose principal place of business is at Queens Gardens, Hull, HU1 3DZ, and a list of the partners of Gosschalks is available for inspection at these offices.
